to. Legis-III(17)/86. The Baluchistan Sea Fisheries (Amendment) BIR, 1986 having been passed by the Provincial Assembly of Baluchistan in 11th February, 1986 and assented to by the Governor of Baluchistan, a nereby published as an Act of the Provincial Assembly.

THE BALUCHISTAN SEA FISHERIES (AMENDMENT) ACT, 1986.

DALUCHISTAN ACT NO. IV OF 1986.

(First published after having received the assent of the Governor of Haluchistan in the Haluchistan Gazette (Extra-ordinary) dated 26th tebruary, 1986.)

AN ACT

further to amend the Haluchistan Sea Fisheries Ordinance, 1974 (IX of 1971).

WHEREAS it is expedient further to umend the Baluchistan Sea Fisheries Ordinance, 1971, in the manner hereinafter appearing.

It is hereby enacted as follows:-

Short title and commencement.

- 1. (1) This Act may be called the Buluchistan Sen Fisheries (Amendment) Act, 1986.
- (2) It shall come into force at once and shall be deemed to have taken effect on the 11th day of September, 1972.

Amendment of section 2 of Ordinance TX of 1971.

2. In the Baluchistan Sea Fisheries Ordinance, 1971, hereinafter referred to as the said Ordinance, in clause (f) of section 2, after the word "includes" the words "a trawler and" shall be inserted.

Amendment of section 3 of Ordinance IX of 1971.

- 3. In the said Ordinance, the existing section 3, shall be numbered as sub-section (1) of that section and after sub-section (1), as so numbered, the following new sub-section shall be added:-
 - "(2)No person shall be allowed to fish with encircting net or improvised purse seine net locally called "wire net" or "gujja" or ring net a bottom trawls locally called "trawls" or "gujja" in the close bays of Sonmiant and Kulmat and twelve nautical miles from shore along the rest of Buluchistan coast."

Amendment of section 9 of Ordinance 1X of 1971.

4. In the said Ordinance, in section 9, the full stop appearing at the end shall be substituted by a colon and thereafter the following proviso shall be added, namply:-

"Provided that the contravention of section 3, shall be punishable with imprisonment of either description for a term which may extend to three years, or with fine which may extend to five thougaind rupees, or with both, and the lishing craft shall be liable to confiscation."

Walidation.

5. In the said Ordinance after section 19, the following new section shall be added, namely:-

"19-A.Any thing done, action taken, obligation, liability, penalty or punishment incurred, or proceedings commenced after the lapse of the Baluchistan

Sea Fisheries (Amendment) Ordinance, 1972 (XI of 1972), under the provisions of the said Ordinance shall be deemed to have been properly and validly done, taken, incurred or commenced, as the case may be, as if this Act was in force on the day on which anything was done, action taken, obligation, liability, penalty or punishment incurred, proceedings commenced."
